WHEREAS, pursuant to Sections 384.84A of the Code of Iowa, notice of the hearing on the proposed issuance of not to exceed \$22,000,000 Stormwater Management Utility Revenue Bonds, and the proposed action by the City Council to institute proceedings for the authorization of the issuance of said Bonds, has been given for the purpose of paying costs of acquisition, construction, reconstruction, extending, remodeling, improving, repairing and equipping all or part of the Stormwater Management Utility, including city-wide stormwater utility improvement projects, Closes Creek watershed improvements, flood mitigation and protection system improvements, and Hamilton Drainage area improvements; and


WHEREAS, no petition has been received calling for the submission of the proposed action to a referendum; and
