**APPROVING SUPPLEMENTAL AGREEMENT NO. 5 TO THE PROFESSIONAL SERVICES AGREEMENT (PSA) WITH BARR ENGINEERING COMPANY FOR ADDITIONAL PROFESSIONAL SERVICES FOR DES MOINES LEVEE ALTERATIONS – PHASE C, FOR AN AMOUNT NOT TO EXCEED \$199,500**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That Supplemental Agreement No. 5 between the City of Des Moines and Barr Engineering Company, John T. Lee, President, 4300 Market Pointe Drive, Suite 200, Minneapolis, Minnesota, 55435, for an additional amount not to exceed \$199,500, based on hourly labor rates and reimbursable costs, for project coordination, cultural resources, plan modifications, project permitting, utility coordination, plat work and related field staking, and bidding coordination for Des Moines Levee Alterations – Phase C, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED: That the Mayor and Acting City Clerk are hereby authorized and directed to execute and attest, respectively, said Supplemental Agreement No. 5 for and on behalf of the City of Des Moines, Iowa.
