APPROVING EXPENDITURES OF ARPA FUNDS

WHEREAS, in March of 2021, the United States Government adopted the American Rescue Plan Act (ARPA) in response to the coninuuing intertwined public health and economic crisis created by COVID-19 and ARPA established the Cononavirus State and Local Fiscal Recovery Funds (SLFRF) to provide state, local, and Tribal governments with the resources needed to respond to the pandemic and its economic effects and to build a stronger, more equitable economy during the recovery; and,

WHEREAS, the City of Des Moines was allocated and has received funds in the amount of \$94,824,614 from SLFRF; and,

WHEREAS, pursuant to the Final Rule of the United States Department of Treasury, allocations and expnditure of the funds must meet specific purposes and occur within specific time limitations as explained in the Council Communication; and,

WHEREAS, the City Manager requests authority to use ARPA funds in the following maximum amounts as approved in the Operating Budget and CIP on March 21, 2022:

- o \$8,000,000 to Stormwater CIP projects for construction
- o \$5,000,000 to Sanitary CIP projects for construction
- o \$350,000 for Library hotspots and CIP project for HVAC costs
- o \$3,000,000 to Neighborhood Development Corporation for three annual contributions of \$1,000,000
- o \$3,000,000 to Neighborhood Development Corporation for additional contributions for projects
- o \$1,500,000 to Neighborhood Finance Corporation for additional contributions for projects
- o \$1,000,000 for contributions to Botanical Center
- o \$1,000,000 for contributions to Blank Park Zoo
- o \$750,000 for contributions to BRAVO; and,
