## APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE BIDDING REQUIREMENTS FOR GOOD CAUSE AND APPROVING PROCUREMENT OF LUCAS COMPRESSION DEVICE SYSTEMS AND RELATED EQUIPMENT AND SERVICES FOR AMBULANCE EMERGENCY MEDICAL SERVICES FROM STRYKER MEDICAL CORP.

**WHEREAS**, the Fire Department has requested the Finance Department's Procurement Division to issue a purchase order for the purchase of eleven (11) Lucas 3, v3.1 Chest Compression Systems, related accessories, and annual preventive maintenance service for the newly procured equipment, in an amount of \$188,712.11; and

WHEREAS, the purchase of such ambulance equipment will assist the Fire Department in replacing inventories of standardized equipment which have met their useful life, maintaining adequate inventories of standardized equipment and related parts, and will allow the Fire Department to equip reserve ambulances that will be deployable in situations where additional ambulances are needed to provide coverage for the City during large scale events; and

**WHEREAS**, the Procurement Administrator has determined that the Lucas 3, v3.1 Chest Compression Systems, related accessories, and equipment annual preventive maintenance service are available from Stryker Medical Corp., 2825 Airview Boulevard, Kalamazoo, MI 49002, the sole source provider of LUCAS Compression System devices and maintenance services; and

**WHEREAS**, in March 2021, the City, through the Fire Department, and Stryker Sales Corporation, through its Medical Division, entered into a ProCare Product Service Plan Agreement ("Agreement") providing for acquisition by the City of the above-described ambulance equipment and maintenance service up to the amount of \$50,000.00; and


**WHEREAS**, Des Moines Municipal Code Section 2-710(a) provides that the City Council may on a case by case basis for good cause shown, exempt contracts for the provision of goods and/or services from the competitive procurement requirements of the Procurement Ordinance, and authorize use of an informal competitive bidding procedure or authorize direct procurement without a competitive process for the procurement of goods and/or services to cost in excess of \$50,000.00; and

WHEREAS, funding in the amount of \$188,712.11, is available from 2022-2026 CIP Page 30, FR013- Equipment Acquisition-Fire Department, Being: G.O. Bonds Issued; and

**WHEREAS**, the City Manager recommends that the procurement of the above-described equipment in excess of \$50,000.00 be exempted from the competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines; and

**WHEREAS**, all ambulance equipment and maintenance services procured will be provided in accordance with the terms and conditions of the Agreement between the City and Stryker Sales Corporation, through its Medical Division.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, that: 1. Good cause has been shown to exempt the procurement of the above-described ambulance equipment and maintenance services exceeding \$50,000.00 from the Procurement Ordinance competitive bidding requirements.
