## HOLD HEARING FOR APPROVAL OF DOCUMENTS FOR VACATION OF ALLEY RIGHT-OF-WAY LOCATED NORTH OF AND ADJOINING 2513 HIGH STREET AND CONVEYANCE TO ROBERT FULLER FOR \$75.00

**WHEREAS,** on June 27, 2022, by Roll Call No. 22-0871 the City Council of the City of Des Moines, Iowa voted to receive and file a recommendation from the City Plan and Zoning Commission to approve a request from Robert Fuller, owner of 2513 High Street, to vacate the east-west alley right-of-way located north of and adjoining a portion of 2513 High Street, subject to the reservation of easements for all existing utilities in place until such time as they are abandoned or relocated; and

WHEREAS, Robert Fuller has offered to the City of Des Moines, Iowa ("City") the purchase price of \$75.00 for the purchase of such vacated right-of-way and previously vacated alley right-of-way located north of and adjoining 2513 High Street (hereinafter "Property") for incorporation into his adjoining property for expanded rear yard, subject to the reservation of easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the alley right-of-way as determined by the City's Real Estate Division; and

**WHEREAS**, there is no known current or future public need for the alley right-of-way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said Property.

WHEREAS, on July 18, 2022, by Roll Call No. <u>22-1141</u>, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed vacation and conveyance of the alley right-of-way be set for hearing on August 8, 2022, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and


**WHEREAS**, due notice of said proposal to vacate and convey the alley right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and
