**RESOLUTION APPROVING EXPANSION OF MCKINLEY SCHOOL/COLUMBUS PARK  
NEIGHBORHOOD BOUNDARIES IN ACCORDANCE WITH THE NEIGHBORHOOD  
RECOGNITION POLICY**

**WHEREAS**, on May 24, 1993, by Roll Call No. 93-2026, the City Council approved the Neighborhood Recognition Policy which establishes procedures and guidelines for formal recognition of neighborhoods by the City of Des Moines, and authorizes recognized neighborhoods to advise the City on issues of concern; and

**WHEREAS**, on May 24, 1993, by Roll Call No. 93-2026, the City Council approved designation of the McKinley School/Columbus Park Neighborhood as a Recognized Neighborhood for the City of Des Moines; and

**WHEREAS**, the McKinley School/Columbus Park Neighborhood has requested a boundary expansion to include the Des Moines River to the north, Hartford Avenue/Indianola Avenue/SW 7<sup>th</sup> Street to the south, SE 14<sup>th</sup> Street to the east, and the Raccoon River to the west, as specifically shown in the accompanying map; and

**WHEREAS**, on August 3, 2022, the Neighborhood Revitalization Board voted to recommend to the City Council that the City of Des Moines expand the boundaries of the McKinley School/Columbus Park Neighborhood as proposed.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that the boundaries of the McKinley School/Columbus Park Neighborhood be hereby expanded according to the attached map with boundaries expanding to reach the Des Moines River between SE 14<sup>th</sup> Street and the Scott Avenue Bridge/Raccoon River to the north; Hartford Avenue between SE 14<sup>th</sup> Street and Indianola Avenue and Indianola Avenue between Hartford Avenue and SW 7<sup>th</sup> Street and SW 7<sup>th</sup> Street between Indianola Avenue and the Raccoon River to the south; SE 14<sup>th</sup> Street between the Des Moines River and Hartford Avenue to the east, and the Raccoon River between Scott Avenue and SW 7<sup>th</sup> Street to the west.
