**RESOLUTION APPROVING THE PURCHASE OF
ONE (1) REPLACEMENT VEHICLE AND SPECIALIZED EQUIPMENT FROM
MACQUEEN EQUIPMENT, AND APPROVING USE OF SOURCEWELL CONTRACT
NUMBER 120721-EVS**

WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division to issue a purchase order for the purchase of one (1) replacement vehicle and specialized sewer televising equipment for use by the Department of Public Works; and

WHEREAS, the Procurement Administrator has determined that the replacement vehicle and specialized sewer televising equipment have been competitively bid and are available from MacQueen Equipment, Inc. (Dan Gage, President/CEO), 4607 SE Rio Ct, Ankeny, IA 50021, an authorized dealer of EnviroSight LLC., using Sourcewell Contract Number 120721-EVS; and

WHEREAS, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the one (1) replacement vehicle and specialized sewer televising equipment is being purchased from MacQueen Equipment, Inc., an authorized dealer of EnviroSight LLC., in the amount of \$302,876.13 utilizing the Sourcewell Contract Number 120721-EVS; and

WHEREAS, funding for the replacement vehicle and specialized sewer televising equipment is available from Fiscal Year 2023 operating budget. I010 FN024024 Equipment Replacement Fund page 80.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The purchase of one (1) replacement vehicle and specialized sewer televising equipment for use by the Department of Public Works from MacQueen Equipment, Inc., at a total cost of \$302,876.13 using Sourcewell Contract Number 120721-EVS is hereby approved.
2. The Finance Department is hereby directed to proceed with negotiation of any agreements or amendments deemed necessary to the existing contract number 120721-EVS between Sourcewell and EnviroSight LLC.
