**RESOLUTION APPROVING THE PURCHASE AND INSTALLATION OF ELECTRIC VEHICLE CHARGING STATIONS IN THE 9<sup>TH</sup> & LOCUST AND THE CENTER STREET PARKING FACILITIES, AND APPROVING USE OF STATE OF IOWA CONTRACT NOS. 20450 AND 20168B**

**WHEREAS**, on April 4, 2022, by Roll Call No. 22-0519, the City Council authorized the submittal of the City’s application to the Iowa Department of Transportation for Iowa Volkswagen Settlement Mitigation Trust for Zero Emission Vehicle Supply Equipment including two (2) Dual Level 2 electric charging stations at both the Center Street Park & Ride and the 9<sup>th</sup> & Locust parking garages; and

**WHEREAS**, on August 8, 2022, by Roll Call No. 22-1260, the City Council approved agreements with the Iowa Department of Transportation for the Iowa Volkswagen Settlement Environmental Mitigation Trust Project and accepted an award of partial funding for installation of said electric vehicle charging stations at their respective locations; and

**WHEREAS**, the Engineering Department’s Traffic and Transportation Division has requested the Finance Department’s Procurement Division issue a purchase order for the purchase and installation of four (4) Dual Level 2 electric vehicle charging stations, with two stations to be installed respectively in the 9<sup>th</sup> & Locust parking garage and in the Center Street Park & Ride facility; and

**WHEREAS**, the Procurement Administrator has determined that the requested electric vehicle charging stations and installation have been competitively bid and are available from Commonwealth Electric Company of the Midwest, 1530 2<sup>nd</sup> Ave., Des Moines, IA 50314 (Michael Price, President), using State of Iowa (DAS) Contract #20450, and from Carbon Day Automotive, 163 S. Wheeling Rd., Wheeling, IL 60090 (Brad Emalfarb, CEO), using State of Iowa (DAS) Contract # 20168B; and

**WHEREAS**, Des Moines Municipal Code Section 2-726 (k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the four (4) electric vehicle charging stations are being purchased from Carbon Day Automotive in the amount of \$42,860.00 utilizing the State of Iowa (DAS) Contract #20168B; and

**WHEREAS**, the installation for the four (4) electric vehicle charging stations is being procured from Commonwealth Electric Company in the amount of \$16,260.00 utilizing the State of Iowa (DAS) Contract #20450 and short-form agreement between the City and Commonwealth Electric of the Midwest as authorized on June 27, 2022 by the City Council pursuant to Roll Call No. 22-1031; and

**WHEREAS**, funding is available from the following funding sources:

\$15,000 – Center Street Park & Ride Parking Garage - Iowa’s Volkswagen Settlement Environmental Mitigation Trust Project funds.

\$15,000 – 9th & Locust Parking Garage - Iowa’s Volkswagen Settlement Environmental Mitigation Trust Project funds.
