**APPROVAL OF PURCHASE AND SALE CONTRACT WITH NATIONWIDE MUTUAL INSURANCE COMPANY FOR THE PURCHASE OF 1200 LOCUST STREET, 1200 MULBERRY STREET, AND ASSIGNMENT OF PARKING LOT LEASE AT 13<sup>TH</sup> STREET AND WALNUT STREET**

**WHEREAS**, Nationwide Mutual Insurance Company “Nationwide” owns property located at 1200 Locust Street (“Office Building”) and 1200 Mulberry Street (“Parking Garage”) and leases a parking lot located at 13<sup>th</sup> Street and Walnut Street (“Parking Lot Lease”) (collectively the “Property”); and

**WHEREAS**, the City has negotiated a Purchase and Sale Contract (“Agreement”) with Nationwide Mutual Insurance Company for the purchase of the Property for \$40,600,000.00, which represents a purchase price of \$30,000,000.00 for the Office Building and Parking Lot Lease and a purchase price of \$10,600,000.00 for the Parking Garage; and

**WHEREAS**, the City intends to use the Property to relocate certain City departments; and

**WHEREAS**, the Agreement allows a due diligence period of nine (9) months, during which the City intends to obtain the financing necessary to complete the purchase and further evaluate the feasibility of the Property for the City’s use; and

**WHEREAS**, in addition, the Agreement requires the City to pay \$106,000.00 in earnest money, to be held in escrow and which shall be refundable during the due diligence period; and

**WHEREAS**, closing on the Office Building and Parking Lot Lease will be June 12, 2023, and closing on the Parking Garage is will be December 31, 2025; and

**WHEREAS**, to account for lack of parking during the gap between the closing dates set forth above, the Agreement further sets forth terms by which Nationwide will lease parking spaces to the City, which lease will be a separate agreement for Council to review and approve following further negotiations of the parties.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that the following Agreement, recommended for approval and acceptance by City staff and on file in the office of the City Clerk, is hereby approved and accepted as follows:

The City Manager, or his designee, is hereby authorized and directed to take all actions necessary to carry out this transaction and is hereby further authorized and directed to sign all necessary real estate documents associated with this acquisition.

The City Manager, or his designee, is directed to submit a copy of the fully executed Agreement to the Finance Department to enable the Finance Director to make any appropriate disclosure filings in accordance with the City's adopted revised Disclosure Policy.

That the Real Estate Division of the Engineering Department is directed to obtain the Legal Department's review and approval of all closing documents prior to closing.

That the City Clerk is hereby authorized and directed to endorse upon the Agreement the approval and acceptance of this Council; the Mayor is authorized and directed to sign all necessary real estate documents associated with this acquisition; and the City Clerk is further authorized and directed to deliver the aforementioned documents to the Real Estate Division Manager, who shall proceed to closing in accordance with standard real estate practices.
