APPROVAL OF THE 2022 CONTINUUM OF CARE (COC) PROGRAM SUPPLEMENTAL SPECIAL UNSHELTERED NOTICE OF FUNDING OPPORTUNITY (NOFO) GRANT APPLICATION TO THE US DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)

WHEREAS, on June 22, 2022, the US Department of Housing and Urban Development (HUD) released a Notification of Funding Opportunity (NOFO) for supplemental Continuum of Care Program funds to target efforts to reduce unsheltered homelessness, particularly in communities with very high levels of unsheltered homelessness and homelessness in rural areas; and

WHEREAS, Homeward facilitated a local competitive grant review process where service providers working with homeless or persons at risk of homelessness submitted proposals, and the Homeward Grant Committee reviewed, scored, and ranked the proposals; and

WHEREAS, on September 26, 2022, the Homeward Board received and approved the Grant Committee's recommendations for the Special Unsheltered NOFO proposals totaling \$4,375,247; and

WHEREAS, the Homeward Board has forwarded the recommendation to City Council to approve the proposals as outlined on the attached Council Communication; and

WHEREAS, the City, as the collaborative applicant, must submit the overall application for the Special Unsheltered NOFO to HUD by October 20, 2022.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the above referenced CoC program application and certifications thereto are hereby approved and ratified, and the City Manager or his designee is hereby directed to execute any necessary documents and submit the application to HUD.
