**RESOLUTION SETTING HEARING REGARDING EXECUTION OF AMENDED AND RENEWED ANNEXATION MORATORIUM AGREEMENT AND 28E AGREEMENT WITH THE CITY OF PLEASANT HILL, IOWA**

**WHEREAS**, the City of Pleasant Hill, Iowa and the City of Des Moines, Iowa desire to enter into an agreement to amend and renew the terms of the Annexation Moratorium Agreement and 28E Agreement first executed July 24, 2000, and again on October 26, 2010, for a period of ten years.

**WHEREAS**, Iowa Code Section 368.4 provides that notice of Annexing Memorandum shall be published in an official county newspaper at least thirty days prior to the action by the City Council;

**WHEREAS**, said Section provides that a copy of the Annexing Memorandum shall be served by regular mail at least thirty days before the hearing on the City Development Board and the Board of Supervisors of the County in which the territory is located; and

**WHEREAS**, the City Council of the City of Des Moines, Iowa deems it appropriate that a public hearing be held on such proposed action.

**NOW THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa as follows:

1. A public hearing before this Council on the Agreement described in the preamble to this resolution is hereby set for 5:00 P.M. on December 12, 2022, in the Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa 50309
2. The City Clerk is authorized and directed to publish and mail notice of such hearing in the form attached hereto at the time and manner required by law
