**APPROVING THE PURCHASE OF WATER LINE INSTALLATION SERVICES FROM WALDINGER CORPORATION AND APPROVING USE OF STATE OF IOWA MASTER AGREEMENT NO. 21012**

**WHEREAS**, the Facilities Division has requested the Finance Department, Procurement Division to issue a purchase order for water line installation services at the City of Des Moines Police Academy facility; and

**WHEREAS**, the Procurement Administrator has determined that the requested services have been competitively bid and are available from by Waldinger Corporation (Thomas Koehn, CEO, 6200 Scout Trail, Des Moines, IA 50321) per the State of Iowa Master Agreement No. 21012 between the State of Iowa and Waldinger Corporation (“Master Agreement”); and

**WHEREAS**, Des Moines Municipal Code Section 2-726(k) provides for the procurement of goods and/or services from contracts established by the State of Iowa Department of Administrative Services, the Iowa Department of Transportation, or the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, funding in the total amount of \$62,983.00 is available from FY2023 Capital Improvement Budget, BL095 Police Academy Improvements, page 53, General Obligations Bonds issue to be transferred from BL062.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

1. The procurement of water line installation services at the City of Des Moines Police Academy facility from Waldinger Corporation for the not-to-exceed amount of \$62,983.00 and per the general terms and pricing of State of Iowa Master Agreement No. 21012 with Waldinger Corporation, is hereby approved.
2. The use of State of Iowa Master Agreement No. 21012 is hereby authorized and approved, subject to modification thereof for the benefit of the City of Des Moines via terms incorporated into a Purchase Order to be issued to Waldinger Corporation for the installation of a water line at the City of Des Moines Police Academy facility as described above.
