RESOLUTION APPROVING THE PURCHASE OF TELEPHONE MAINTENANCE AND SUPPORT SERVICES FOR SIEMEN'S TELEPHONE EQUIPMENT AND SYSTEM THROUGH NORSTAN COMMUNICATIONS, INC. D/B/A BLACK BOX NETWORK SERVICES PER THE 2021 MASTER ORDER AGREEMENT

WHEREAS, the Information Technology Department has requested the Finance Department's Procurement Division issue a purchase order for Telephone Maintenance and Support Services for Siemen's Telephone Equipment; and

WHEREAS, the Telephone Maintenance and Support Services for Siemen's Telephone Equipment are being procured through the 2021 Master Order Agreement, as approved by the City Council on June 14, 2021, by Roll Call No. 21-0880, for a three-year term; and

WHEREAS, the Telephone Maintenance and Support Services for Siemen's Telephone Equipment are being purchased from Norstan Communications, Inc. d/b/a Black Box Network Services (EV Styles, CEO, 1000 Park Drive, Lawrence, PA 15055-1018), in the amount of \$72,603.00 per the 2021 Master Order Agreement; and

WHEREAS, funding for the Telephone Maintenance and Support Services for Siemen's Telephone Equipment is available from Fiscal Year Adopted Operating Budget 2023, Information Technology Department, Telephone Communication Fund, I033, IT154000, page 121.
