FOR AN AMOUNT NOT TO EXCEED \$1,745,500**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That Supplemental Agreement No. 6 between the City of Des Moines and Barr Engineering Company, Ward Swanson, President, 4300 Market Pointe Drive, Suite 200, Minneapolis, Minnesota, 55435, for an additional amount not to exceed \$1,745,500, based on hourly labor rates and reimbursable costs, for construction administration, construction observation, and survey work necessary to verify the Project is constructed in accordance with the approved Plans and Specifications and to develop the necessary documentation for the Federal Emergency Management Agency (FEMA) to accredit the Des Moines Levee Alterations Phase C levee section after the completion of the entire levee system modification for Des Moines Levee Alterations – Phase C, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED: That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Supplemental Agreement No. 6 for and on behalf of the City of Des Moines, Iowa.
