APPROVING THE PURCHASE OF SIX (6) HEAVY DUTY CHASSIS FOR THE PUBLIC WORKS DEPARTMENT IN THE AMOUNT OF \$1,968,051.00

WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division issue a purchase order for the purchase of six (6) heavy duty truck replacements with solid waste collection bodies, dump bodies and snowplows, and forestry aerial lift for use by the Sanitation, Street Cleaning and Forestry Divisions of the Public Works Department.

WHEREAS, Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the six (6) heavy truck chassis, with one (1) being upfitted with a forestry aerial lift, are being purchased from Housby Mack Inc. (4747 NE 14th Street, Des Moines, IA 50313, Kelly Housby, CEO), in the amount of \$1,080,621 utilizing Sourcewell contract number 060920-MAK; and

WHEREAS, two (2) chassis will be upfitted with manual automated side loading solid waste collection bodies and two (2) chassis will be upfitted with front loading refuse bodies purchased from and installed by McNeilus Truck and Manufacturing, (520 Highway, Suite E, Dodge Center, MN 55927, Brad Nelson, President), in the amount of \$742,652 utilizing Sourcewell contract number 091219-MCN; and

WHEREAS, one (1) chassis will be upfitted with a dump body and snow plow equipment purchased from and installed by Henderson Products Inc. (916 South 10th Street, Manchester, IA 52057, John Sievert, President), in the amount of \$144,778 utilizing Sourcewell contract 080818-HPI; and

WHEREAS, funding is available from FY2022-2023 Operating Budget, from Equipment Replacement Fund, page 83.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of six (6) heavy truck chassis with solid waste collection bodies, dump bodies and snowplows, and forestry aerial lift for use by the Sanitation, Street Cleaning and Forestry Divisions of the Public Works Department in the amount of \$1,968,051.
