RESOLUTION HOLDING CONTINUED HEARING REGARDING REQUEST FROM THE GREATER DES MOINES PARTNERSHIP AND CITY OF DES MOINES FOR REVIEW AND RECOMMENDATION TO ADOPT THE DOWNTOWNDSM: FUTURE FORWARD PLAN AS AN ELEMENT OF PLANDSM: CREATING OUR TOMORROW COMPREHENSIVE PLAN

WHEREAS, on April 25, 2016, by Roll Call No. 16-0717, the City Council adopted the PlanDSM: Creating Our Tomorrow Comprehensive Future Land Use Plan ("PlanDSM: Creating Our Tomorrow"); and

WHEREAS, in 2021, the Greater Des Moines Partnership launched the DowntownDSM: Future Forward ("Downtown Plan") planning effort in 2021 in collaboration with Bravo Greater Des Moines, Catch Des Moines, Capital Crossroads, City of Des Moines, Des Moines Area Regional Transit Authority (DART), Des Moines Downtown Chamber of Commerce, Des Moines Area Metropolitan Planning Organization (MPO), FuseDSM, Operation Downtown and Polk County; and

WHEREAS, the focus of the initiative was to formulate a community-driven plan, positioning Downtown for short-term economic recovery and long-term vibrancy and vitality while acknowledging important historical and ongoing related planning efforts; and

WHEREAS, the proposed Downtown Plan includes generally, in addition to the Downtown, a larger area roughly bounded by MLK Jr Parkway, East 14th Street, University Avenue, and the Des Moines and Raccoon Rivers; and


WHEREAS, the Downtown Plan is proposed to be adopted as an element of PlanDSM: Creating Our Tomorrow; and

WHEREAS, at a public hearing held on December 15, 2022, the City Plan and Zoning Commission has advised that its members voted 10-0-1 in support of a motion to recommend **APPROVAL** to adopt the Downtown Plan as an element of PlanDSM: Creating Our Tomorrow; and

WHEREAS, on January 9, 2023, by Roll Call No. 23-0028, it was duly resolved by the City Council that the request for approval and adoption of proposed adoption of the Downtown Plan is to be considered be set down for hearing on January 23, 2023, in the Council Chambers at City Hall; and

WHEREAS, on January 23, 2023, by Roll Call No. 23-0127, it was duly resolved by the City Council that the hearing regarding the approval and adoption of proposed adoption of the Downtown Plan be continued to February 6, 2023, in the Council Chambers at City Hall; and

WHEREAS, due notice of said hearing was published in the Des Moines Register, as provided by law, setting forth the time and place for hearing on said Downtown Plan; and

- 2. That the proposed adoption of the Downtown Plan as an element of the PlanDSM: Creating Our Tomorrow, as described above, is hereby **APPROVED**.
