APPROVING ARPA FUNDING AGREEMENT WITH DES MOINES PUBLIC SCHOOLS FOR EXPANDED PRESCHOOL SERVICES FOR SIX ADDITIONAL CLASSROOMS

WHEREAS, on March 11, 2021, Congress enacted the American Rescue Plan Act of 2021 ("ARPA") to provide relief to combat the continued impact of COVID-19 on the economy, public health, state and local governments, individuals, and businesses; and

WHEREAS, the City has received ARPA funding from the Coronavirus State and Local Fiscal Recovery Funds and the City desires to aid nonprofit organizations to address the disparate inequities that impacted the Des Moines community; and

WHEREAS, Des Moines Public Schools ("DMPS") seeks to expand partial day preschool classes to full day for six additional classrooms ("Project"); and

WHEREAS, the Project seeks to provide early educational opportunities within the Des Moines community that presently do not exist; and

WHEREAS, the Project will serve the public purposes of supporting local public schools, providing educational opportunities; and

WHEREAS, the City desires to enter into an ARPA Funding Agreement ("Agreement") to provide a financial grant in the amount of \$3,300,000 in support of the Project, to be paid over time to DMPS as the project progresses; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The Grant Agreement between the City and DMPS for the Project for a grant not to exceed \$3,300,000 is hereby approved in the material form as attached to this roll call (the "Agreement.")
- 2. The City Manager or his designee are authorized to negotiate non-substantive changes to specific terms of the attached agreement subject to approval as to form by the Legal Department.
- 3. Any material changes to the Agreement, as determined by the City Manager must be submitted to the City Council for additional review and approval.
