APPROVING ARPA FUNDING AGREEMENT WITH DES MOINES PUBLIC SCHOOLS FOR AN RFP AND RFI PROCESS IN SUPPORT OF EXPANDING PRESCHOOL AND ASSOCIATED WRAP AROUND CARE

WHEREAS, on March 11, 2021, Congress enacted the American Rescue Plan Act of 2021 (“ARPA”) to provide relief to combat the continued impact of COVID-19 on the economy, public health, state and local governments, individuals, and businesses; and

WHEREAS, the City has received ARPA funding from the Coronavirus State and Local Fiscal Recovery Funds and the City desires to aid nonprofit organizations to address the disparate inequities that impacted the Des Moines community; and

WHEREAS, Des Moines Public Schools (“DMPS”) seeks to expand partial day preschool classes to full day, including wrap around care through a \$1,000 per year per student scholarship for families at 200% of poverty and below, which shall be 3-year grant opportunity to be administered collaboratively with an RFP and RFI process (“Project”); and

WHEREAS, the Project seeks to provide early educational opportunities, including wrap around care, to families in need within the Des Moines community; and

WHEREAS, the Project will serve the public purposes of supporting local public schools, providing educational opportunities to the City’s most financially vulnerable families, and supporting working families with wrap around care opportunities; and

WHEREAS, the City desires to enter in to a ARPA Funding Agreement (“Agreement”) to provide a financial grant in the amount of \$600,000 in support of the Project, to be paid upon DMPS’s award made pursuant to the RFP and RFI process; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The Finance Director is hereby authorized and directed to expend ARPA federal funds received by the City from the U.S. Department of Treasury, OMB Number 1505-0271, titled Corona Virus Local Fiscal Recover Fund, in an amount not to exceed \$600,000.00 in accordance with the terms of the Agreement.
2. The Grant Agreement between the City and DMPS for the Project for a grant not to exceed \$600,000 is hereby.

- 5. Upon execution by DMPS and approval by the Legal Department as to form, the Mayor is hereby authorized and directed to sign the Agreement, and the City Clerk is hereby authorized and directed to attest to the Mayor's signature.
