APPROVING ARPA FUNDING AGREEMENT WITH DES MOINES AREA RELIGIOUS COUNCIL

WHEREAS, on March 11, 2021, Congress enacted the American Rescue Plan Act of 2021 ("ARPA") to provide relief to combat the continued impact of COVID-19 on the economy, public health, state and local governments, individuals, and businesses; and

WHEREAS, the City has received ARPA funding from the Coronavirus State and Local Fiscal Recovery Funds and the City desires to aid nonprofit organizations to address the disparate inequities that impacted the Des Moines community; and

WHEREAS, Des Moines Religious Council ("DMARC") seeks to provide food and personal hygiene items to citizens of Des Moines in need ("Project"); and

WHEREAS, the Project will serve the public purposes of meeting basic human needs for the Des Moines community; and

WHEREAS, the City desires to enter in to a ARPA Funding Agreement ("Agreement") to provide a financial grant in the amount of \$300,000 in support of the Project, to be paid within thirty days of the date the City executes the Agreement; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The Finance Director is hereby authorized and directed to expend ARPA federal funds received by the City from the U.S. Department of Treasury, OMB Number 1505-0271, titled Corona Virus Local Fiscal Recover Fund, in an amount not to exceed \$300,000.00 in accordance with the terms of the Agreement.
- 2. The Grant Agreement between the City and DMARC for the Project for a grant not to exceed \$300,000 is hereby approved and, subject to the Legal Department's approval of the Agreement as to form, the Mayor is hereby authorized and directed to sign said Agreement, and the City Clerk is hereby authorized and directed to attest to the Mayor's signature.
