APPROVAL OF SECOND AMENDED AND RESTATED RECEIPT OF A CERTIFIED LOCAL GOVERNMENT (CLG) GRANT AWARD FROM THE STATE HISTORICAL SOCIETY OF IOWA TO THE CITY OF DES MOINES TO PARTIALLY FUND DEVELOPMENT OF A CITY-WIDE HISTORIC PRESERVATION PLAN

WHEREAS, the City of Des Moines has been deemed a Certified Local Government (CLG) by the State Historical Society of Iowa; and,

WHEREAS, the State Historical Society of Iowa provides funding to CLG's for historic preservation projects and activities; and,

WHEREAS, on March 22, 2021, by Roll Call No. 21-0463, the City Council of the City of Des Moines, Iowa, approved the receipt of a CLG award (“Agreement”) from the State Historical Society of Iowa to the City of Des Moines to partially fund development of a city-wide historic preservation plan and authorized proceeding with RFP for professional services to assist with plan development; and

WHEREAS, on June 13, 2022, by Roll Call No. 22-0921, the City Council of the City of Des Moines, Iowa, approved the amended and restated receipt of the Agreement; and

WHEREAS, the parties need to further extend certain dates in the Agreement.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

That the Mayor is hereby authorized and directed to sign the second amended and restated CLG Grant-In-Aid Agreement from the State Historical Society of Iowa, including but not limited to electronic signature.
