## APPROVING THE ANNUAL AGREEMENT FOR CONCRETE CONSTRUCTION SERVICES WITH J&J CONSTRUCTION CORP. AND NEUMANN BROTHERS, INC. TO BE USED BY THE PARKS AND RECREATION DEPARTMENT AND THE CITY MANAGER, FACILITIES DIVISION FOR A TOTAL ESTIMATED ANNUAL AMOUNT OF \$270,000.00

WHEREAS, the Parks and Recreation Department and the Facilities Division wish to utilize a secondary supplier when the primary supplier is unable to provide the needed services, or is unable to provide them in the time requested; and

WHEREAS, the overall second low dollar compliant bid for concrete construction services was received from Neumann Brothers, Inc., 1435 Ohio Street, Des Moines, IA 50314, Mike Simpson, President & CEO; and

WHEREAS, funding is available from various Parks and Recreation and various Facilities capital improvement projects for a total estimated annual amount of \$270,000.00; and

WHEREAS, the Procurement Administrator, Parks and Recreation Department and Facilities Division recommends approval of the contract awards to the low dollar and second low dollar compliant bids received for various concrete construction services.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, hereby accepts and approves the awards to the aforementioned low dollar primary and secondary suppliers, at an annual estimated cost of up to \$270,000.00, and further authorizes the Procurement Administrator to enter into annual agreements renewable for four (4) additional twelve (12) month periods, with price increases complying with agreement terms.
