2023 HMA RESURFACING PROGRAM CONTRACT 2  
AND FIXING A DATE FOR RECEIVING OF BIDS ON APRIL 11, 2023  
AND PUBLIC HEARING ON MAY 08, 2023  
ENGINEER'S ESTIMATE IS \$1,125,000**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following improvement:

2023 HMA Resurfacing Program Contract 2, 062022008

The improvements include scarification of existing asphalt streets, furnish and place Hot Mix Asphalt (HMA), furnish and place pavement markings, traffic control and other incidental items, all in accordance with the contract documents, including Plan File No. 654-178/208, at the following locations and other locations directed by the Engineer in Des Moines, Iowa:

1. 43th Street - Ingersoll Avenue to Grand Avenue
2. 27th Street and Lincoln Avenue - Allison Avenue to 26th Street
3. Center Street - 12th Street to 15th Street
4. Pioneer Road - SE 6th Street to Indianola Avenue
5. Watrous Avenue - SW 14th Street to Fleur Drive
6. SW 10th Place - Southdale Drive to County Line Road
7. SW 11th Street - Southdale Drive to County Line Road

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$1,125,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Engineer; and that payment for the cost of said improvement shall be paid from the funding source identified below.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be held in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 5:00 p.m. on May 08, 2023, at which time this Council will consider any objections offered thereto or to the making of said improvement.
