**APPROVING AND AUTHORIZING THE EXECUTION OF IOWA DEPARTMENT OF
TRANSPORTATION AGREEMENT NUMBER 1-22-STPU-042
FOR THE GUTHRIE AVENUE BRIDGE REHABILITATION OVER THE
UNION PACIFIC RAILROAD, WHICH RESCINDS IOWA DEPARTMENT OF
TRANSPORTATION AGREEMENT NUMBER 1-21-STBG-SWAP-017**

WHEREAS, on July 19, 2021, by Roll Call No. 21-1089, the City Council approved Iowa Department of Transportation (IDOT) Agreement No. 1-21-STBG-SWAP-017 for the Guthrie Avenue Bridge Rehabilitation over the Union Pacific Railroad project; and

WHEREAS, due to the implementation of the Infrastructure Investment and Jobs Act (IIJA), the IDOT requires that the previously approved IDOT Agreement No. 1-21-STBG-SWAP-017 be rescinded and replaced with a new Federal-aid funded agreement under IDOT Agreement No. 1-22-STPU-042, for the Guthrie Avenue Bridge Rehabilitation over the Union Pacific Railroad; and

WHEREAS, the new IDOT project number for this project is STP-U-1945(859)--SG-77, which replaces the previously assigned IDOT Project Number STBG-SWAP-1945(859)--SG-77.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That Agreement No. 1-21-STBG-SWAP-017, approved on July 19, 2021, by Roll Call No. 21-1089, between the City of Des Moines and the Iowa Department of Transportation for the Guthrie Avenue Bridge Rehabilitation over the Union Pacific Railroad, is hereby rescinded by agreement in the new Agreement No. 1-22-STPU-042 between the City of Des Moines and the Iowa Department of Transportation for the Guthrie Avenue Bridge Rehabilitation over the Union Pacific Railroad.
2. That Agreement No. 1-22-STPU-042 between the City of Des Moines and the Iowa Department of Transportation for the Guthrie Avenue Bridge Rehabilitation over the Union Pacific Railroad, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
3. That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Agreement No. 1-22-STPU-042 for and on behalf of the City of Des Moines, Iowa.
