APPROVING ARPA FUNDING AGREEMENT WITH BOYS & GIRLS CLUBS OF CENTRAL IOWA, INC. FOR A SUMMER YOUTH CLEANUP PROGRAM

WHEREAS, on March 11, 2021, Congress enacted the American Rescue Plan Act of 2021 ("ARPA") to provide relief to combat the continued impact of COVID-19 on the economy, public health, state and local governments, individuals, and businesses; and

WHEREAS, the City has received ARPA funding from the Coronavirus State and Local Fiscal Recovery Funds and the City desires to aid nonprofit organizations to address the disparate inequities that impacted the Des Moines community; and

WHEREAS, Boys & Girls Clubs of Central Iowa, Inc. ("Agency") seeks to implement a six week long summer youth cleanup project whereby approximately 120 middle school aged students will have the opportunity to earn money over the summer of 2023 by beautifying neighborhoods, parks and campuses within the City of Des Moines ("Project"); and

WHEREAS, the Project will serve the public purposes of beautifying neighborhoods within the City of Des Moines, making them cleaner, safer, and more vibrant; and

WHEREAS, the City desires to enter in to a ARPA Funding Agreement ("Agreement") to provide a financial grant in the amount of \$85,300 in support of the Project; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The Finance Director is hereby authorized and directed to expend ARPA federal funds received by the City from the U.S. Department of Treasury, OMB Number 1505-0271, titled Corona Virus Local Fiscal Recover Fund, in an amount not to exceed \$85,300.00 in accordance with the terms of the Agreement.
- 2. The Grant Agreement between the City and Agency for the Project for a grant not to exceed \$85,300 is hereby approved and, subject to the Legal Department's approval of the Agreement as to form, the Mayor is hereby authorized and directed to sign said Agreement, and the City Clerk is hereby authorized and directed to attest to the Mayor's signature.
