## APPROVING THE PURCHASE OF PLAYGROUND EQUIPMENT FOR MCHENRY PARK FROM LANDSCAPE STRUCTURES INC. (LSI) C/O OUTDOOR RECREATION PRODUCTS, APPROVING THE USE OF THE NATIONAL COOPERATIVE PURCHASING ALLIANCE CONTRACT (NCPA) NUMBER 10-03, AND AUTHORIZING NEGOTIATION AND EXECUTION OF SUPPLEMENTAL AGREEMENT WITH LANDSCAPE STRUCTURES, INC.

WHEREAS, the Parks and Recreation Department requested the Finance Department, Procurement Division to procure Landscape Structures playground equipment, play structures and freestanding play features as part of the McHenry Park Playground Improvements, to be installed as a volunteer park project in fall 2023; and

WHEREAS, the Procurement Administrator has determined that the requested Landscape Structures playground equipment has been competitively bid and is available from Landscape Structures c/o Outdoor Recreation Products, Steve King, Founder, Chairman of the Board, 601 7th Street South Delano, MN 55328, using NCPA cooperative purchasing contract to provide playground and outdoor fitness equipment, site accessories, surfacing, and related products and services between Landscape Structures c/o Outdoor Recreation Products and Region XIV Education Service Center, Abilene, TX (Contract No. 10-03) as amended; and

WHEREAS, Des Moines Municipal Code Section 2-726(m) provides for the procurement of goods or services from contracts that have been competitively established through cooperative group contracting consortiums for State government departments, institutions, agencies and political subdivisions, such as NCPA Contract through Region XIV Education Service Center, Abilene, TX, without conforming to the competitive bidding requirements of the Procurement Division; and


