ACCEPTANCE OF A PROPOSAL FROM MIDAMERICAN ENERGY COMPANY TO REPLACE 16 EXISTING STREETLIGHT POLES AND INSTALL 12 NEW STREETLIGHT POLES FOR E. COURT AVENUE RECONSTRUCTION FROM THE DES MOINES RIVER TO E. 7th STREET, ESTIMATED AT \$191,264.55

WHEREAS, reconstruction of E. Court Avenue from the Des Moines River to E. 7th Street requires replacing 16 existing streetlight poles and installing 12 new streetlight poles; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to replace and install the streetlight poles; and

WHEREAS, the proposal provides that MidAmerican Energy Company's estimated cost to replace and install the street lights poles is \$191,264.55; and

WHEREAS, the proposal provides that since the estimated cost of construction is over \$100,000, the City is required by tariff to pay actual costs upon completion of the work, which could result in an increase or decrease in the estimated cost of \$191,264.55 to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- 1. That the proposal from MidAmerican Energy Company to the City of Des Moines for replacing 16 existing streetlight poles and installing 12 new streetlight poles for E. Court Avenue Reconstruction from the Des Moines River to E. 7th Street, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content, and accepted.
- 2. That the Mayor is hereby authorized and directed to sign the proposal for and on behalf of the City of Des Moines, Iowa.
- 3. That the Engineering Department is authorized to administer the terms specified in the proposal.
- 4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for the actual costs upon receipt of an invoice acceptable to the Engineering Department.
