APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE BIDDING REQUIREMENT AND AUTHORIZING THE EXECUTION OF AN AGREEMENT BY AND BETWEEN THE CITY OF DES MOINES, IOWA, AND THE DES MOINES INDEPENDENT COMMUNITY SCHOOL DISTRICT FOR SHARING THE COST OF THE SCHOOL CROSSING GUARD PROGRAM

WHEREAS, the City desires to reimburse the Des Moines Independent Community School District for half the cost of operating a school crossing guard program at high traffic locations near the school buildings to allow for the safe passage of students and staff to and from school; and

WHEREAS, previously, the City of Des Moines contracted with an outside vendor, ACMS to handle school crossing guard services where the District and the City entered into a split cost sharing agreement which ended August 2022; and

WHEREAS, the District agreed to take over the contract and the City agreed to reimburse the District. On August 23, 2022, the District's Board approved an agreement with ACMS for a temporary term while a request for proposals was issued. On August 6, 2022 a public solicitation delivered two responses, both proposals were carefully reviewed and the District's Board found it was in the best interest of the District to award school crossing guard services to ACMS for the remainder of FY22-23 school year and FY23-24; and

WHEREAS, Municipal Code section 2-726(b)(19) provides that the procurement administrator is hereby expressly authorized to procure from any federal, state, county or local government unit or agency thereof, without conforming to the competitive bidding requirements of this division, such goods and/or services as are authorized by the city manager, provided that the city manager determines and declares in writing that such goods and/or services were competitively procured by such unit or agency pursuant to competitive procurement procedures substantially equivalent to those set forth in this division, and can be procured without mark-up from such other federal, state, county, or local government unit or agency; and

WHEREAS, the City Manager supports this service being procured and finds that such services were competitively procured by the District pursuant to competitive procurement procedures substantially equivalent to those set forth in Des Moines Municipal Code; and

WHEREAS, funding is available from City of Des Moines Adopted Operating Budget FY2023, page 182; and

WHEREAS, said reimbursement will require a Cost Sharing Agreement between the City and the Des Moines Independent Community School District; and
