RESOLUTION FOR RECERTIFICATION OF RECOGNIZED NEIGHBORHOODS

WHEREAS, on May 24, 1993, by Roll Call No. 93-2026, the City Council approved the Neighborhood Recognition Policy which establishes procedures for the formal recognition of neighborhoods by the City of Des Moines, and authorizes recognized neighborhoods to advise the City on issues of concern; and

WHEREAS, the Neighborhood Recognition Policy requires that each recognized neighborhood complete and return an annual neighborhood survey to the Neighborhood Services Department; and

WHEREAS, during the 2023 annual neighborhood survey process, Neighborhood Services staff received completed surveys from recognized neighborhoods; and

WHEREAS, the below neighborhoods are found to be in compliance with the Neighborhood Recognition Policy and it is recommended to the City Council that the City of Des Moines recertify the following 49 Recognized Neighborhoods:
