APPROVING WATER QUALITY INITIATIVE URBAN CONSERVATION DEMONSTRATION PROJECTS COST-SHARE GRANT CONTRACT WITH IOWA DEPARTMENT OF AGRICULTURE AND LAND STEWARDSHIP IN THE AMOUNT OF \$250,000 FOR THE GLENDALE CEMETERY WET POND REHABILITATION PROJECT

WHEREAS, the Parks and Recration Department submitted an application to the Iowa Department of Agriculture and Land Stewardship for a Water Quality Initiative Targeted Demonstration Watershed project grant for the Glendale Cemetery Wet Pond Rehabilitation for the City's Glendale Cemetery Wet Pond Rehabilitation project ("Project"); and

WHEREAS, Iowa Department of Agriculture and Land Stewardship (IDALS) has approved the City's Water Quality Initiative grant application for the Project in the amount of \$250,000.00 and has prepared a Cost-Share Grant Contract for such Project, a copy of which is on file in the City Clerk's Office, which Contract includes, among other terms, the obligation of the City to indemnify IDALS in regard to the Contract including City's activities with subgrantees and third parties in regard to the Contract and conflict of interest prohibitions; and

WHEREAS, the Public Works Department recommends approval of this Contract as the Project should result in improved water quality in the Glendale Cemetery pond, the Waveland Creek watershed, the Waveland Golf Course pond, Walnut Creek and the Raccoon River.
