RESOLUTION APPROVING THE PURCHASE OF HIGH-STRENGTH GROUT FOR THE PUBLIC WORKS DEPARTMENT FROM AP/M PERMAFORM, THE SOLE AREA-WIDE PROVIDER

WHEREAS, Public Works Department Sewers Division requested the Finance Department Procurement Division to issue a blanket purchase order in the amount of \$150,000.00 for high-strength grout products, for use with previously purchased sewer manhole rehabilitation equipment, to be used during fiscal year 2024; and

WHEREAS, the Procurement Administrator has determined that high-strength grout products are available from AP/M Permaform, (PO Box 555, Johnston, IA 50131-0555), Bill Shook, President, the sole area-wide distributor until equipment warranty has expired; and

WHEREAS, Municipal Code Section 2-726 (a)(7) provides for a non-competitive procurement of goods and/or services that are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing city need, materials or equipment to be cost effective; and

WHEREAS, funding for said purchase is available from FY2023-2024 Operating Budget, Page 209, Public Works Department, Des Moines Sanitary Sewer Maintenance PW247461/532050.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, hereby accepts and approves:

- 1. The procurement of high-strength grout products during the fiscal year 2024 from AP/M Permaform, at a total estimated annual cost of \$150,000.00, is hereby approved.
- 2. The Public Works Director is further authorized to approve and issue future purchase orders for high-strength grout products from AP/M Permaform for an annual not-to-exceed amount of \$150,000.00 plus up to five percent increase per year through fiscal year 2028, provided funding is available in the budget approved by the City Council for each such year.
