APPROVING THE PURCHASE OF AUTO BODY REPAIR SERVICES FOR VARIOUS CITY DEPARTMENTS FROM STEW HANSEN DODGE CITY IN THE ANNUAL ESTIMATED AMOUNT OF \$350,000.00

WHEREAS, the Department of Finance, Procurement Division was requested to issue an annual blanket purchase order for Auto Body Repair Services for use by various City Departments for Fiscal Year 2024; and

WHEREAS, Municipal Code section 2-726 (k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the Auto Body Repair Services are being provided by Stew Hansen Dodge City, 12103 Hickman Road, Des Moines, IA 50323 (Dan Boettcher, General Manager), in the estimated annual amount of \$350,000.00 utilizing the State of Iowa (DAS) purchasing contract number 22044 and City of Des Moines Short Form #K22-304; and

WHEREAS, funding is available from Fiscal Year 2024 Operating Budget, Fleet Service Maintenance, I010 FN024020, Equipment Maintenance Center Fund, page 84.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, approves the purchase of Auto Body Repair Services from Stew Hansen Dodge City in the total estimated annual amount of \$350,000.00 using the State of Iowa (DAS) purchasing contract number 22044 and the City of Des Moines short form #K22-304. The Finance Department is hereby directed to proceed with the issuance of a blanket purchase order for Fiscal Year 2024.
