HOLD HEARING FOR LICENSE AGREEMENT WITH DES MOINES ART CENTER, FOR INSTALLATION, MAINTENANCE AND DISPLAY OF ARTWORK ON THE MECHANICAL BUILDING WITHIN EVELYN K. DAVIS PARK

WHEREAS, the City of Des Moines owns and maintains the Mechanical Building within the Evelyn K. Davis Park ("City Property") in Des Moines as parkland; and

WHEREAS, Des Moines Art Center ("hereinafter Licensee") desires to enter into a License Agreement with the City of Des Moines to install, maintain and display a new public art mural installation on the side of the Mechanical Building within the Evelyn K. Davis Park created by artists Siri Garcia, Marissa Hernandez, and Jill Wells; and

WHEREAS, the Greater Des Moines Art Foundation ("GDMAF") has the responsibility to conduct the affairs and activities of the Public Art Program under an amended Contract approved by the City Council by Roll Call No. 04-145 on July 12, 2004, which includes the duty to prepare recommendations for the City Council's consideration for proposed public arts related projects; and

WHEREAS, the GDMAF has advised the City Council by letter, in form attached hereto, following their July meeting that the proposed installation of the artwork on the licensed premises is consistent with the standards of the public art program and recommends that the City approve the installation; and

WHEREAS, a License Agreement has been prepared which provides that the Des Moines Art Center will retain ownership and have maintenance responsibility for the mural for the time period of the License Agreement, which is currently until August 15, 2026 with an option of one (1) additional two (2) year renewal, a copy of which License Agreement is available for public review in the City Clerk's Office; and

WHEREAS, it is in the best interest of the City to enter into an agreement with the Des Moines Art Center to allow the display and maintenance of the mural in consideration of the enjoyment of the public and the maintenance obligations to be undertaken by the Des Moines Art Center; and

WHEREAS, on June 26, 2023 by Roll Call No. 23-0901, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed License Agreement be set down for hearing on July 17, 2023, at 5:00 p.m., in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to enter into a License Agreement with Des Moines Art Center as given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed agreement, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.
