**APPROVING AND AUTHORIZING THE EXECUTION OF IOWA DEPARTMENT OF
TRANSPORTATION AGREEMENT NUMBER 1-22-STPU-041
FOR THE WALNUT STREET BRIDGE REPLACEMENT OVER THE DES MOINES RIVER,
WHICH RESCINDS IOWA DEPARTMENT OF TRANSPORTATION AGREEMENT NUMBER
1-21-STBG-SWAP-016**

WHEREAS, on July 19, 2021, by Roll Call No. 21-1088, the City Council approved Iowa Department of Transportation (IDOT) Agreement No. 1-21-STBG-SWAP-016 for the Walnut Street Bridge Replacement over the Des Moines River project; and

WHEREAS, due to the implementation of the Infrastructure Investment and Jobs Act (IIJA), the IDOT requires that the previously approved IDOT Agreement No. 1-21-STBG-SWAP-016 be rescinded and replaced with a new Federal-aid funded agreement under IDOT Agreement No. 1-22-STPU-041, for the Walnut Street Bridge Replacement over the Des Moines River; and

WHEREAS, the new IDOT project number for this project is STP-U-1945(858)--SG-77, which replaces the previously assigned IDOT Project Number STBG-SWAP-1945(858)--SG-77.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That Agreement No. 1-21-STBG-SWAP-016, approved on July 19, 2021, by Roll Call No. 21-1088, between the City of Des Moines and the Iowa Department of Transportation for the Walnut Street Bridge Replacement over the Des Moines River, is hereby rescinded by agreement in the new Agreement No. 1-22-STPU-041 between the City of Des Moines and the Iowa Department of Transportation for the Walnut Street Bridge Replacement over the Des Moines River.
2. That Agreement No. 1-22-STPU-041 between the City of Des Moines and the Iowa Department of Transportation for the Walnut Street Bridge Replacement over the Des Moines River, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
3. That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Agreement No. 1-22-STPU-041 for and on behalf of the City of Des Moines, Iowa.
