RESOLUTION APPROVING THE PURCHASE OF CISCO CATALYST 9300 AND 9400 NETWORK HARDWARE FROM HEARTLAND BUSINESS SYSTEMS USING STATE OF IOWA CONTRACT #21294

WHEREAS, the Information Technology Department has requested the Finance Department's Procurement Division to issue a purchase order for the purchase Cisco Catalyst 9300 and 9400 network hardware; and

WHEREAS, the Procurement Administrator has determined that the requested Cisco Catalyst 9300 and 9400 network hardware has been competitively bid and is available from a Cisco Systems, Inc authorized reseller, Heartland Business Systems, (Peter Helander, CEO, 108 3rd Street, Suite 300, Des Moines, Iowa 50309) using State of Minnesota NASPO ValuePoint Master Agreement (Contract No. AR3227) between Cisco Systems, Inc. and the State of Minnesota ("NASPO Agreement") and the Master Agreement between Cisco Systems, Inc. and the State of Iowa (No. 21294)("State Contract"); and

WHEREAS, Des Moines Municipal Code Section 2-726(k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance, and Section 2-726(m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the Cisco Catalyst 9300 and 9400 network hardware is being purchased from Heartland Business Systems, in the total amount of \$177,347.38 utilizing the NASPO Agreement and State Contract; and

WHEREAS, funding for said purchase is available from CIP FY23-FY24, MS001, C051IT99, Enhanced Information and Communication System, pg 36.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, hereby accepts and approves the purchase of Cisco Catalyst 9300 and 9400 network hardware from Heartland Business Systems, a Cisco Systems, Inc. authorized reseller, in the total amount of \$177,347.38 and per the general terms and pricing of the NASPO Agreement No. AR3227 and State of Iowa Contract No. 21294, is hereby approved.
