WHEREAS, the Information Technology Department has requested the Finance Department's Procurement Division to issue a purchase order for the purchase of annual software maintenance and support services for Geographic Information System (GIS) software licensed by Environmental Systems Research Institute (ESRI) Inc. for a period of three years with optional annual renewals; and

WHEREAS, the Procurement Administrator has determined that the requested software maintenance and support services for Geographic Information System (GIS) are uniquely compatible with existing City needs and are available for purchase from Environmental Systems Research Institute (ESRI) Inc. (Jack Dangermond, President/Redlands, CA); and

WHEREAS, Des Moines Municipal Code Section 2-726 (d) provides for the exemption of the request for proposals process when the procurement of goods and/or services that are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing City needs, materials or equipment to be cost effective; and

WHEREAS, the software maintenance and support services for Geographic Information System (GIS) is being purchased from Environmental Systems Research Institute (ESRI) Inc., in the amount of \$445,000.00 for the initial three year term; and

WHEREAS, funding for said purchase is available from FY24 Adopted Operating Budget, Information Technology Department, Geographic Information Systems, G001, IT151000, pg 126.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

- 1. The purchase of annual software maintenance and support services for Geographic Information System (GIS) software from Environmental Systems Research Institute (ESRI) Inc., in the total amount of \$445,000.00 for the initial three-year term, is hereby approved.
- 2. The Finance Department and Information Technology Department are hereby authorized and directed to proceed with negotiation of an agreement between the City and Environmental Systems Research Institute (ESRI) Inc., and the City Manager is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
- 3. The City Manager is authorized and directed to approve and execute up to seven annual renewals in annual not-to-exceed amounts of up to \$181,500.00, provided funding is budgeted for and services will be used as the City's enterprise GIS and the Des Moines Area Regional GIS, subject to approval as to form by the Legal Department.
