WHEREAS, if approved, the proposed conveyance by the City to R.M. Madden Construction, Inc. will be governed by and subject to approval of a development agreement between R.M. Madden Construction, Inc. and the City of Des Moines, which agreement will be submitted to City Council for consideration concurrently with the public hearing on the sale; and

WHEREAS, deed restrictions, a permanent easement and compliance with the conditions of the development agreement will be included in the deed conveying the R.M. Madden Construction, Inc.; and

WHEREAS, there is no known current or future public need for the Property proposed to be sold and the City will not be inconvenienced by the sale of said Property; and

WHEREAS, on September 11, 2023, by Roll Call 23-1247, it was duly resolved by the City Council that the proposed conveyance of the R.M. Madden Construction, Inc. be set down for hearing on October 2, 2023, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of the proposal was published as provided by law in the Des Moines Register, setting forth the time and place for hearing on the proposal; and

WHEREAS, in accordance with City Council direction, those interested in this proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.
