**APPROVING COMPLETION AND ACCEPTANCE OF THE
PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED
PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, WOODBURY PLAT 1,
BETWEEN ALLIANCE CONSTRUCTION GROUP, L.L.C. AND QSL DEVELOPMENT, L.L.C.**

WHEREAS, on April 19, 2021 under Roll Call No. 21-0604, the City Council approved a private construction contract in the amount of \$303,850.00, between Alliance Construction Group, L.L.C., Dustin Jones, President, 9400 Plum Drive, Suite 100, Urbandale, IA, 50322 as Contractor, and QSL Development, L.L.C., 475 SE Alice's Road, Waukee, IA, 50263 as Owner, for construction of Paving Improvements described as paving improvements located south of E. Douglas Avenue and east of E. 56th Street, to serve the proposed Woodbury Plat 1 Phase 1 single family residential development, as shown on Plan File Number 619-180/197, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Paving Improvements in the amount of \$303,850.00, which have been constructed in substantial compliance with the contract documents between Alliance Construction Group, L.L.C.. and QSL Development, L.L.C., which were approved under Roll Call No. 21-0604 , dated April 19, 2021, be received and filed; and that completion of said Paving Improvements described as paving improvements located south of E. Douglas Avenue and east of E. 56th Street, to serve the proposed Woodbury Plat 1 Phase 1 single family residential development, as shown on Plan File Number 619-180/197, is hereby acknowledged and that said Paving Improvements are hereby accepted.
