SET HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF VACATED ALLEY RIGHT-OF-WAY LOCATED EAST OF AND ADJOINING 737 SOUTHEAST 26^{TH} COURT TO HENRY A. ARTERO AND CELINA QUIJANO FOR \$25.00

WHEREAS, on October 8, 2001, by Roll Call No. 01-3083, the City Council of the City of Des Moines, Iowa voted to pass Ordinance No. 14,002 vacating the north-south alley right-of-way between East 26th Court and East 27th Street running north of Maury Street, and dead-ending at the railroad right-of-way, including that portion lying east of and adjoining 737 Southeast 26th Court, subject to the reservation of easements for public utilities then in place with right of entry for servicing same; and

WHEREAS, Henry A. Artero and Celina Quijano, owners of 737 Southeast 26th Court, Des Moines, Iowa, have offered to the City of Des Moines ("City") the purchase price of \$25.00 for the purchase of the portion of the vacated alley right-of-way lying east of and adjoining their property at 737 Southeast 26th Court (hereinafter "Property"), for assemblage with 737 Southeast 26th Court, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Property proposed to be sold, and the City will not be inconvenienced by the sale of said Property.
