WHEREAS, HUD has published its 2024 Fair Market Rents, and the DMMHA payment standards; and

WHEREAS, the DMMHA has again reviewed the current payment standards and believe no changes are needed in the current payment standards that were effective January 1, 2023; and

WHEREAS, the DMMHA payment standards are still within the HUD required range of 90% to 110% of the 2024 HUD-established FMR's.

NOW, THEREFORE, BE IT RESOLVED, by the Municipal Housing Governing Board of the City of Des Moines, Iowa, that there will be no change to Des Moines Municipal Housing Agency payment standards effective January 1 2024, as they are already in compliance with the HUD-established 2024 Fair Market Rents.
