APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, 4102 NORTH UNION STREET, BETWEEN DEWIT CONSTRUCTION, LLC AND TRUE BIBLE BAPTIST CHURCH

WHEREAS, on September 13, 2021 under Roll Call No. 21-1392, the City Council approved a private construction contract in the amount of \$25,138.00, between deWit Construction, LLC, Neil deWit, Owner, 2510 160th Street, Van Meter, IA, 50261 as Contractor, and True Bible Baptist Church, Rod Bradley, President, 4101 Amherst, Des Moines, IA, 50313 as Owner, for construction of Paving Improvements described as Paving Improvements to serve True Bible Baptist Church, located at 4102 North Union Street, as shown on Plan File numbers 608-222/230, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.


