RESOLUTION APPROVING THE PURCHASE OF M500 IN-CAR VIDEO SYSTEMS AND VIDEO MANAGER FROM MOTOROLA SOLUTIONS, INCORPORATED, APPROVING USE OF SOURCEWELL MASTER AGREEMENT CONTRACT #010720-WCH, AND APPROVING SUPPLEMENTAL AGREEMENT

WHEREAS, the Police Department has requested the Finance Department's Procurement Division issue a purchase order for the purchase of M500 In-Car Video System and Video Manager as well as a five (5) year subscription for service and maintenance; and

WHEREAS, the Procurement Administrator has determined that the requested M500 In-Car Video System and Video Manager have been competitively bid and are available from Motorola Solutions, Inc. (500 W. Monroe St. Suite 4400 Chicago, Il 60661, Greg Brown CEO), using the Sourcewell Master Agreement Contract #010720-WCH: and

WHEREAS, Municipal Code section 2-726 (b20) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, such as Sourcewell, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the Procurement Division has negotiated a Short Form Agreement between the City and Motorola Solutions, Inc, on file in the office of the City Clerk, to supplement the Sourcewell Master Agreement, with terms specific to the City's procurement: and

WHEREAS, the M500 In-Car Video System and Video Manager, a five (5) year subscription for service and maintenance are being purchased from Motorola Solutions Inc. in the amount of \$1,500,080.00 utilizing the Sourcewell Master Agreement Contract #010720-WCH; and

WHEREAS, funding is available from FY 2024 Adopted Operating Budget, General Fund.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Des Moines, Iowa, that:

1. The purchase of M500 In-Car Video System and Video Manager from Motorola Solutions, Inc. in the amount of \$1,500,080.00 and per the terms and pricing of the Sourcewell Master Agreement Contract #010720-WCH for use by the Police Department, is hereby approved.
2. The Mayor is authorized and directed to execute the Short Form Agreement and Addendum on file with the City Clerk, supplementing Sourcewell Master Agreement Contract #010720-WCH with term specific to the City's procurement, on behalf of the City.
