RESOLUTION APPROVING THE PURCHASE OF REPLACEMENT CONSTRUCTION EQUIPMENT FROM ZIEGLER CAT INC., AND APPROVING USE OF SOURCEWELL CONTRACT NUMBER 032119-CAT

To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department and Fleet Division are hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and Ziegler CAT Inc., supplementing Sourcewell Contract No. 032119-CAT, and the Finance Director is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
