HOLD HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF A PERMANENT EASEMENT FOR UNDERGROUND ELECTRIC LINES IN A PORTION OF COLUMBUS PARK TO MIDAMERICAN ENERGY COMPANY FOR \$2,200

WHEREAS, the City of Des Moines is the owner of certain parkland located in Columbus Park, 1921 SE 1st Street, Des Moines, Iowa ("Property"); and

WHEREAS, MidAmerican Energy Company has requested a permanent easement across a portion of Columbus Park property located outside of the right-of-way at the southeast corner of Southeast 1st Street and Indianola Avenue in order to relocate existing electric lines; and

WHEREAS, there is no known current or future public need for the property interests proposed to be conveyed, and the City will not be inconvenienced by the conveyance of an Easement for Underground Electric Lines in the portion of Columbus Park; and

WHEREAS, on November 6, 2023 by Roll Call No. 23-1539, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed conveyance be set down for hearing on November 20, 2023, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to convey the Easement was given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed conveyance of a permanent Easement for Underground Electric Lines in a portion of Columbus Park, as described herein, are hereby overruled and the hearing is closed.
- 2. There is no public need or benefit for the property interest proposed to be conveyed, and the public would not be inconvenienced by reason of the conveyance of a permanent Easement for Underground Electric Lines in a portion of Columbus Park, 1921 SE 1st Street, Des Moines, Iowa, as legally described, to MidAmerican Energy Company, for \$2,200.00 and said conveyance is hereby approved:

- 5. The Real Estate Division Manager is authorized and directed to forward the original of the Easement for Underground Electric Lines, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.
- 6. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Easement for Underground Electric Lines and copies of the other documents to the Grantee.
- 7. Proceeds from the sale of these easements will be deposited into the Parks and Recreation Capital Projects fund C040, Park Infrastructure Project PK175.
