AUTHORIZING CITY MANAGER TO NEGOTIATE AND EXECUTE AN ESTOPPEL AGREEMENT AND GRANT AGREEMENT WITH AHEPA 192-IV, INC., AHEPA 192-IV APARTMENTS GP, LLC, AND AHEPA 192-IV APARTMENTS, LP FOR AN AFFORDABLE SENIOR HOUSING FACILITY

WHEREAS, AHEPA 192-IV APARTMENTS, INC., AHEPA 192-IV APARTMENTS GP, LLC, AND AHEPA 192-IV APARTMENTS, LP (collectively "AHEPA") is proposing the construction of a new 3-floor affordable senior housing facility at the property locally known as 1111 East Army Post Road, Des Moines, Iowa (the "Project"), which will consist of 90 dwelling units; and


WHEREAS, on May 8, 2023, the Des Moines City Council approved authorizing the City Manager to negotiate and execute a grant agreement with AHEPA192-IV, LP; and

WHEREAS, since such approval, AHEPA has requested a different AHEPA entity be used and has requested an estoppel agreement be provided by the City; and

WHEREAS, the City is supportive of this request, subject to approval of both documents by the City's Legal Department.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The Grant Agreement between the City and AHEPA 192-IV APARTMENTS, INC., AHEPA 192-IV APARTMENTS GP, LLC, AND AHEPA 192-IV APARTMENTS, LP, for the grant of an amount not to exceed \$400,000 and the City Estoppel Agreement, both subject to the Legal Department's approval of the Agreement as to form, are hereby approved and the Mayor is hereby authorized and directed to sign both documents.
