APPROVING WOODS OF COPPER CREEK PLAT 7 FINAL PLAT AND ACCEPTANCE OF SUBDIVISION BOND

WHEREAS, the final subdivision plat entitled Woods of Copper Creek Plat 7, for property located in the vicinity of 2806 Brook View Drive, to be developed by DR Horton Iowa, LLC, 1910 SW Plaza Shops Lane, Ankeny, Iowa. 50023, Anastasia Smith, authorized agent, was submitted to the Development Services Department on April 27, 2023; and,

WHEREAS, the City Plan and Zoning Commission approved the preliminary subdivision plat on June 2, 2011; and,

WHEREAS, the Planning and Urban Design Division has recommended conditional approval of the final subdivision plat, subject to acceptance of final legal documents by the City Legal Department; and,

WHEREAS, subject to the conditions identified below, the said subdivision plat conforms to Iowa Code Sections 355.8, 354.6, and 354.11, and said subdivision plat conforms to the standards and conditions set forth in Chapter 106 of the Municipal Code of the City of Des Moines, Iowa; and,

WHEREAS, the City Engineer has approved the amount of the security for subdivision improvements.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. It is hereby determined that the subdivision plat identified above conforms to the PlanDSM: Creating Our Tomorrow Plan and the subdivision, with the required installation of public improvements, will not unduly burden public improvements in the area and will provide an appropriate balance of interests between current proprietors, future purchasers and the public interest.
- 2. Subdivision bond number SU1199474 from Arch Insurance Company, in the amount of \$117,700.00 is hereby accepted and approved as adequate public security for the completion of the required public improvements including public sidewalk within the plat.
- 3. The Mayor and City Clerk are hereby authorized and directed to execute approval on all copies of said subdivision plat as appropriate.
- 4. The City Clerk is hereby directed to provide the approved subdivision plat, a certified copy of this resolution, the attorney's title opinion and the attachments to the plat to the Developer for delivery to the County Recorder for recording by the plat proprietors. The

The Permanent Easements for public utilities, gas, and conservation that have been provided incident to said subdivision plat are hereby approved and accepted subject to the final approval of the City Legal Department, and the City Clerk is hereby authorized and directed to certify to the City's acceptance on such agreement upon approval by the City Legal Department.
