

RESOLUTION RELEASING SUBDIVISION BOND AND PUD RESTORATION BOND FOR WOODS OF COPPER CREEK PLAT 4

WHEREAS, on June 25, 2018, by Roll Call Number 18-1059 the City Council approved the subdivision bond and PUD restoration bond for the development entitled Woods of Copper Creek Plat 4, located in the vicinity of the 4700 block of NE 23rd Avenue (Easton Boulevard), to be developed by HDR Land Development, LLC, Larry Handley, Authorized Agent, and accepted bond number NIA2056 from Merchants Bonding Company, to secure the satisfactory completion and payment of the required sidewalk improvements and bond number NIA1925 from Merchants Bonding Company, to secure the satisfactory completion and payment of the required sidewalk improvements and bond number NIA1925 from Merchants Bonding Company, to secure the satisfactory completion and payment of the required grading, erosion control, and site restoration; and,
