**RESOLUTION RELEASING SUBDIVISION BOND & PUD RESTORATION BOND  
FOR WOODS OF COPPER CREEK PLAT 5**

WHEREAS, on November 1, 2021, by Roll Call Number 21-1650 the City Council approved the subdivision bond and PUD restoration bond for the development entitled Woods of Copper Creek Plat 5, located in the vicinity of the 4700 block of NE 23<sup>rd</sup> Avenue (Easton Boulevard), to be developed by DR Horton-Iowa LLC, Anastasia Smith, Authorized Agent, and accepted bond number SUR0070214 from Argonaut Insurance Company to secure the satisfactory completion and payment of the required sidewalk improvements and bond number SUR0070215 from Argonaut Insurance Company to secure the satisfactory completion and payment of the required grading, erosion control, and site restoration; and,

WHEREAS, the City Engineer has certified that the sidewalk improvements, grading, erosion control, and site restoration have been completed and recommends that the securities be released;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That Subdivision Bond number SUR0070214 in the amount of \$161,120.00 from Argonaut Insurance Company and PUD Restoration Bond number SUR0070215 in the amount of \$131,970.00 from Argonaut Insurance Company are hereby released as securities for the satisfactory completion of the sidewalk improvements, grading, erosion control, and site restoration.
