## RESOLUTION APPROVING AN AMENDMENT TO THE TYLER TECHNOLOGIES ENERGOV PERMITTING AND LICENSING (EPL) AGREEMENT IN THE AMOUNT OF \$51,048.00

WHEREAS, in 2018, the Information Technology Department requested the Finance Department, Procurement Division to procure an Enterprise Permitting, Inspection and Licensing System; and

WHEREAS, a Request for Proposals was issued by the City on August 28, 2017, with six proposals received, and on August 6, 2018, by Roll Call No. 18-1359, the City Council accepted the proposal submitted by Tyler Technologies, Inc., One Tyler Drive, Yarmouth, Maine, 04096 and authorized the City Manager to negotiate and execute any amendments or addendums to the resulting Agreement up to \$50,000 annually; and

WHEREAS, the Information Technology Department wishes to amend said Agreement to purchase one site license for Community Development and Workforce Mobile in lieu of named user licenses in an amount over \$50,000; and

WHEREAS, the Information Technology Department and Procurement Division have negotiated an Amendment to the Agreement to replace the named user licensing model with a site licensing model for a one-time fee of \$51,048.00, with an overall decrease of the annual maintenance and support costs for EPL by \$7,115.50; and

WHEREAS, funding for said purchase is available from Fiscal Year (FY) 2023-2024 Operating Budget, Information Technology, G001, IT152000, Enterprise Application Development, page 127.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

- 1. The Amendment to the Tyler Technologies EnerGov Permitting and Licensing Agreement to replace the named user licensing model to a site licensing model for a onetime fee of \$51,048.00, in form on file in the office of the City Clerk, is hereby approved.
- 2. The City Manager is hereby authorized and directed to execute said Amendment, and the Procurement Division and Information Technology Department are authorized and directed to administer said Agreement as amended.
