**ACCEPTANCE OF A PROPOSAL FROM
MIDAMERICAN ENERGY COMPANY TO
INSTALL STREETLIGHTS ON
BROADWAY AVENUE FROM
2nd AVENUE TO HUBBELL AVENUE,
ESTIMATED AT \$295,551.61**

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install 50 streetlights; and

WHEREAS, the proposal provides that MidAmerican Energy Company's estimated cost to install the streetlights is \$295,551.61; and

WHEREAS, the proposal provides that since the estimated cost of construction is over \$100,000, the City is required by tariff to pay the actual costs upon completion of the work, which could result in an increase or decrease in the cost to the City; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installation of 50 streetlights on Broadway Avenue from 2nd Avenue to Hubbell Avenue, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content, and accepted.
2. That the Mayor is hereby authorized and directed to sign the proposal for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for the actual costs upon receipt of an invoice acceptable to the Engineering Department.
