**SET HEARING FOR APPROVAL OF ENTERING INTO A WAIVER OF DISTANCE SEPARATION EASEMENT AGREEMENT WITH AND CONVEYING TO THE DES MOINES METROPOLITAN WASTEWATER RECLAMATION AUTHORITY A WAIVER OF DISTANCE SEPARATION EASEMENT AND ACKNOWLEDGEMENT BY DES MOINES REGIONAL TRANSIT AUTHORITY ON PROPERTY LOCATED AT 3500 VANDALIA ROAD FOR \$1.00.**

**WHEREAS**, the City of Des Moines, Iowa, (“City”) is the owner of certain excess real estate locally known as 3500 Vandalia Road, Des Moines, Iowa; and

**WHEREAS**, the Des Moines Metropolitan Wastewater Reclamation Authority has requested the City enter into the Waiver of Distance Separation Easement Agreement (“Agreement”), granting the Waiver of Distance Separation Easement before conveying the property to Des Moines Regional Transit Authority (“DART”). DART has signed acknowledging the Waiver of Distance Separation Easement Agreement and being bound by the terms of the Agreement; and

**WHEREAS**, the Easement is being conveyed in accordance with Iowa Code §364.7(3) for \$1.00 and other good and valuable consideration.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council of the City of Des Moines, Iowa, proposes to enter into the Waiver of Distance Separation Easement Agreement with and conveying to the Des Moines Metropolitan Wastewater Reclamation Authority a Waiver of Distance Separation Easement with acknowledgement made by Des Moines Regional Transit Authority, on property located at 3500 Vandalia Road, for the consideration identified and legally described below:

Grantee: Des Moines Metropolitan Wastewater Reclamation Authority

Consideration: \$1.00

Legal Description: LOTS 67-73, AND LOT 74, EXCEPT THE SOUTH 150’ THEREOF, AND LOTS 75-102, AND VACATED LOTS A, B AND VACATED LOT D, EXCEPT THE EAST 25’ THEREOF, ALL IN VANDALIA ACRES PLAT 2, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

2. A public hearing shall be held on March 4, 2024, at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa. At that time the City Council will consider the above-described proposal and any other(s) submitted prior to or during the public hearing.
